DEFINITIONS OF TESTS

OPEN – Open to all dogs and handlers but if oversubscribed preference will be given to dogs which have gained an award or COM at a Field Trial, been placed 1st, 2nd or 3rd in an open GWT or won a novice GWT

NOVICE – Only for dogs which have not gained an award or COM at a Field Trial, or 1st in a Novice GWT

PUPPY – Dog/bitch under 18 months old on the day of the test

VETERAN – Dog/bitch 8 years or over on the day of the test

All doges must be registered with The Kennel Club.
Bitches in season will not be allowed on the ground.
